Nominations for the offices of President, Secretary-Treasurer, Recording Secretary, five (5) Vice Presidents, and one hundred (100) Executive Board members will be accepted from the floor at the April 2015 membership meeting at the date, time, and place indicated below. Nominations shall be in writing designating the names of the person nominated, the office for which they are nominated, and must be signed by at least three percent (3\%) of the full dues paying membership in good standing ( 688 signatures based on the membership reported on December 2014 of 22,912 members in good standing) with at least ten (10) signatures from each of four (4) separate bargaining units. The candidate for office must sign such written nomination to indicate a willingness to become a candidate.

Nomination petitions must be presented to the presiding officer at the meeting or mailed. If mailed, nomination petitions must be mailed by registered mail, return receipt requested, to Recording Secretary Chris Bondi, SEIU Local 73, 300 S. Ashland, Suite 400, Chicago, IL 60607, at least ninety-six (96) hours prior to the time of the membership meeting.

Eligibility of nominations shall be determined by the Executive Board within three (3) days after nominations are closed. Nominees who are declared ineligible shall be notified promptly. Appeals or withdrawals shall be made in writing by registered mail, return receipt requested, to the Executive Board no later than three (3) days after receiving notice.

No person shall be eligible for nomination or be a candidate for any office unless that person has been a member of the Union in good standing continuously for at least two (2) years prior to the time of nomination and has attended at least two (2) membership meetings in the twelve (12) months prior to the nominating meeting, unless excused in writing by the President or the Executive Board.

In the event only one (1) candidate is nominated for the offices of President, Secretary-Treasurer, or Recording Secretary, or only five (5) candidates are nominated for the offices of Vice President, or only one hundred (100) candidates are nominated for the Local 73 Executive Board, no election shall be conducted for such office unless required by law. Such unopposed candidates shall be declared elected by acclamation at the nominations meeting effective as of the conclusion of the term of the previous incumbent.

In the event that more than one (1) candidate is nominated for the offices of President, SecretaryTreasurer, or Recording Secretary, or more than five (5) candidates are nominated for the offices of Vice President, or more than one hundred (100) candidates are nominated for the Executive Board, an Election Committee shall be selected and you will be provided further notice of the election.
