Dear Officer Nominees:

Please read this communication in its entirety as there are three distinct sections in this communication. The first section, Section A, lists the Officer positions for which there will be an election and lists the eligible candidates for each position. The second section, Section B, lists the positions in which no election will be run as there are fewer eligible candidates than there were open positions. The third section lists the determination of the Elections Committee in regard to eligibility appeals.

A. Officer Positions for which an election will be held
